

Jackson's Kennel Full Registration Agreement

Jackson's Kennel is proud to provide quality dogs fit for a wide variety of sports and jobs. A Jackson's Kennel Doberman is subject to release of full registration if specific terms and conditions are met and a fee of \$1000. All dogs or bitches to be granted full registration must be of breed standard description, have completed all acceptable health testing and have earned at least one acceptable title from any circuit or discipline (not just AKC and conformation).

Co-own terms: A dog or bitch may be co-owned with full registration by Kalee Jackson and the purchaser/owner until proof of completion of the required health testing and one title has been provided. No litters will be approved until the proof of completion of the required health testing and one title has been provided. The \$1000 fee is paid at the time of purchase.

No Co-own: A dog or bitch may be purchased with intent to have full registration at a later date. Full registration will be released once proof of health testing and one title has been provided. The \$1000 is paid at the time proof of health testing and title is provided

Acceptable Health Testing:

- Genetic panel of VWD, DCM1, DCM2, DvDob, Narcolepsy, OCA, and COI
- OFA Congenital Cardiac Screening
- Echo and Holter*
- OFA Prelim Hips, OFA Hips or Pennhip Certification
- OFA Eye Certification
- Kidney & Liver panel

*Dogs under 1 yr old must have an OFA Preliminary Cardiac Evaluation completed in place of an echo and holter. Dogs under 2 years old may have an OFA Basic Cardiac Evaluation completed in place of an echo and holter.

Jackson's Kennel is not responsible for the cost nor reimbursement of health testing the dog or bitch seeking full registration. Full registration is not guaranteed. The dog or bitch must have adequate passing results to qualify for full registration. Co-owned full registration dogs will not have single-ownership released if they fail to meet adequate passing results. No refund will be given for the purchased \$1000 as the dog is already granted full registration. NO litter will be approved to a co-owned dog/bitch that has inadequate health testing results. Examples of inadequate results: hip disease including but not limited to hip dysplasia, hereditary eye disease severely impairing vision or expected to impair vision, progressive eye disease, DCM diagnosis, Wobblers (CSM) diagnosis, kidney/liver disease, sour, skittish or aggressive temperament, doesn't conform to the breed standard.
